It is to inform that online scholarship applications under **Central Sector Scheme of Scholarship (CSSS)** for College and University Students sponsored by the Ministry of Human Resource Development (MHRD), New Delhi through the Jammu and Kashmir State Board of School Education are being invited through **National Scholarship Portal (<http://scholarships.gov.in>)** by or before **31st October 2017** for the students who have passed their Higher Secondary Examination, Part-II(Class 12th) Session Annual, Regular, 2016, Kashmir Division/Winter Zone of Jammu Division and Annual Regular 2017 in case of Summer Zone areas of Jammu Division.

The quantum of Scholarship is Rs 10,000/-per annum for undergraduate courses i.e Rs 30,000/- for three years and Rs 20,000/-per year during post graduate courses.

The selection of candidates shall be strictly as per the State Quota (768) and as per the merit (top 20th Percentile) in respective categories in class 12th, separately for Boys and Girls in the ratio of 1:1 and will be granted as per the ratio of 3:2:1 in Science, Commerce and Humanities Streams respectively. The list of eligible candidates in respective categories in class 12th who can submit their forms online is given on JKBOSE website: www.jkbose.co.in.

Other Eligibility Criteria:

1. The overall family income should not exceed Rs 6 Lacs per annum.
2. The student should not be availing any other scholarship from any other source.
3. The student should be pursuing undergraduate courses in any stream from recognized institution within or outside J&K State.

Besides, it is also notified for information of all the concerned candidates of **1st Renewal 2016 Batch and 2nd Renewal of 2015 Batch**, who are in receipt of Central Sector Scheme of Scholarship (CSSS) that they can also submit online applications for the respective renewal installments on **National Scholarship Portal (<http://scholarships.gov.in>)** by or before **31st August 2017**.

The application after successful completion would be then available for online submission to the university/college/institute in which the student is studying at graduate level. Students have to get their online applications verified by their respective institutions.
