Fee charged by the affiliating Universities shall be collected from the students during admission in addition to the above fee. The existing charges for application forms for admission to a course (for centralized admission)/admission to a particular College plus cost of prospectus of about one hundred pages should not exceed Rs. 100.00.

As recommended by the Fees fixation Committee constituted by Govt. Order No. 280-HE of 2019 dated 16.05.2019, the fee shall be enhanced @ 10% every next academic year.
